

These agencies (except for USDA Rural Development) are Rural Preservation Companies receiving funding through the NYS Division of Housing and Community Renewal to provide technical assistance on a variety of housing related services,

community development, grant application assistance, grant administration, historic preservation, fair housing and housing counseling.

HOUSING COUNSELING SERVICES:

The Housing Assistance Program of Essex County, Inc. (HAPEC) is a HUD Housing Counseling Agency, employing certified counselors providing housing counselling, free of charge. These services are extremely important since they give the housing consumer a technical expert to help negotiate housing issues. Counseling functions include:

Fair Housing Counseling:

Counselors understand the Fair Housing Act, its provisions, and its exceptions. They can assist in identifying possible cases of discrimination and can help clients in filing complaints with the appropriate agencies.

• Financial Management:

Counselors can assist clients in achieving their financial goals through budget coaching and helping them to establish and maintain good credit. Financial counseling is also a good way to develop strategies to safeguard and build assets.

Housing Affordability:

Counselors can help clients to determine how much they can afford to spend on housing as well as what type of housing is appropriate to their circumstances.

• Tenancy:

Counselors are knowledgeable about lease agreements as well as tenant and landlord rights and responsibilities. They can assist in resolving disputes. They can also help clients transition from homelessness and secure affordable rental housing.

• Homeownership: Pre-Purchase to Post-Purchase Counseling:

Counselors are well versed in the home purchase process and can assist clients through all the steps from mortgage readiness, to financing, to shopping, to closing. They can also convey the responsibilities of homeownership and help clients to develop strategies to protect their investment.

• Foreclosure Intervention:

Counselors understand mortgage underwriting and potential options for homeowner in default, foreclosure, or simply feel their mortgage payment is unaffordable. A counselor can advise, guide and assist clients in working with their mortgage company and explain the foreclosure process.

FINANCIAL CAPABILITY/COACHING:

This program is for clients who are having trouble "making ends meet," planning for a large purchase, or interested in improving their credit. Counselors can assist by:

- Provide a financial assessment
- Preform a credit review
- Advise on realistic financial goals
- Guide strategy development
- Assist in disputing credit reporting errors

HOMEBUYER ASSISTANCE PROGRAM:

Homebuyer Education:

This in-person educational class is available to all, even if participants are not interested or eligible for further financial assistance. The class provides potential homeowners with knowledge about the purchase process including affordability, money management, financing, shopping, and closing.

Homebuyer Education is also available online through a partnership with eHome America, a HUD approved web based platform. For more information go to: www.ehomeamerica.org/hapec.

Essex and Clinton County Homebuyer Assistance:

The programs are designed to make home ownership affordable to low and moderate income families by providing financial help. This financial benefit is in the form of a deferred payment loan. Funding may be used for principle reduction, closing costs and repairs to address building code, health, safety and energy shortfalls.

The program assist household that meet income and credit criteria. It is not a requirement when applying to the program to be mortgage ready, just a willingness to work toward that goal. A prerequisite is to participate in homebuyer education.

Adirondack Community Housing Trust (ACHT)

Homeownership in the Adirondacks is being priced out of reach for many local working families. The mission of the Adirondack Community Housing Trust is to create an inventory of adequate housing stock for purchase at affordable prices.

Through an initiative by New York State Senator Betty Little, the State budgeted \$1 million to be used by an "Adirondack Community Housing Trust" to reduce the cost of home purchases. Resale limitations on the

property require that future sales of these homes be controlled by ACHT so that they will be passed on to other income-qualified families at affordable prices.

RURAL DEVELOPMENT (RD)

The USDA Rural Development Section 502 Program is available to low and very low-income households. This program can finance the purchase of a home and needed repairs or new construction. Applicants must have good credit and the ability to repay the loan. The maximum loan amount is \$180,900 (Essex County).

HOUSING REHABILITATION & REPAIR

Owner-occupied housing rehabilitation and repair assistance is available to low- and moderate-income households through a variety of local, state, and federal sources. These programs vary in availability, eligibility requirements, locations, and types of repairs. The most readily available programs are shown below.

New York State CDBG Small Cities Program

Under the Small Cities Community Development Block Grant Program (CDBG), a community is able to design a comprehensive community development strategy addressing such issues as housing rehabilitation, public infrastructure improvements and economic revitalization.

New York State Access to Home Program

The New York State HOME Program provides funds to communities and not-for-profit agencies to assist homeowner and Reuters with disabilities to make their homes more accessible.

NYS RESTORE Program

RESTORE Program provides funds for the cost of emergency repairs to eliminate hazardous conditions in homes owned by the elderly when the homeowners cannot afford to make the repairs in a timely fashion. To be eligible for assistance, homeowners must be 60 years of age or older and have a household income that does not exceed 50 percent of the area median income. Work undertaken cannot exceed \$9,500.00 per building. Typical repairs include repairs to plumbing, heating systems, electrical systems, and roofs.

Rural Development

The USDA Rural Development Section 504 Loan and Grant program is available to very low-income households for home repairs. The loan program offers 1% interest loans for a term of up to 20 years. The grant program is available to home owners 62 years of age or over who cannot repay a loan. Grant funds may be used to remove identified health and safety hazards.

MOBILE AND MANUFACTURED HOME REPLACEMENT

The Mobile and Manufactured Home Replacement program assists low- and moderate-income homeowners to replace dilapidated mobile or manufactured homes that are sited on land owned by the homeowner with a new manufactured, modular or site-built home.

Eligible participants must meet the criteria below:

- The property is the primary residence of the homeowner, and the existing unit is sited on land owned by the homeowner;
- The homeowner has a household income that does not exceed eighty percent (80%) of the area median income.

Costs related to the replacement of dilapidated mobile or manufactured homes will be eligible for grant reimbursement. These costs include, but are not limited to:

- Demolition, removal, disposal of the dilapidated units;
- Purchase and site prep for new unit;
- Temporary relocation assistance
- Permitting, environmental review and testing.

DEFAULT/FORECLOSURE INTERVENTION PROGRAM

Whether you are in default, foreclosure, or simply feel your mortgage payments is unaffordable. A counselor will advise, guide, and assist you in working with your mortgage company by:

- Assessing the situation
- Performing a financial assessment and credit review
- Communication with the mortgage servicer
- Reviewing possible options
- Preparing and submitting loss mitigation application
- Assist in filing complaints when appropriate
- Explaining the NYS foreclosure process
- Accessing emergency funds like NYS Mortgage Assistance Program (MAP), when available

ASSISTANCE FOR THE ELDERLY

The Essex County Office for the Aging (OFA) advocates for older adults in Essex County to assure they receive services for which they are entitled. OFA provides services for *residents 60 years of age and older* including: information and referrals, outreach, transportation and legal assistance.

Applications for the Home Energy Assistance Program (HEAP) are accepted by OFA. Elderly Pharmaceutical Insurance Coverage (EPIC) offers cost sharing prescription drug coverage for adults over 65.

Expanded In-Home Services for the Elderly Program (EISEP) offers non-medical homemaker and personal care services. The Nutrition Program provides home delivered meals and congregate meals. OFA funds 12 meal sites throughout the county to provide low cost meals for older adults in a social setting. Meal sites are operated by ACAP.

ENERGY ASSISTANCE

Weatherization Assistance Program (WAP)

This program enables low-income families to reduce their heating and cooling costs by making their homes more energy efficient. Weatherization promotes a "whole house approach" utilizing a several methods for reducing energy consumption including a comprehensive energy audit of the home.

EmPower NY

Focusing on electric reduction measures, EmPower also addresses shell and heating systems to reduce the household energy burden. They work with a network of weatherization agencies and private contractors - all are certified by Building Performance Institute (BPI). In addition to a "whole-house" approach to energy-saving, contractors also address health and safety issues where applicable. EmPower New York works closely with the Weatherization Assistance Program (WAP) to coordinate funding for low-income households.

Energy Services

Energy Services are available to anyone who does not meet the criteria for any of the programs mentioned above. There is an established fee for performing a comprehensive audit and write up. Any of the work which is recommended through the auditing process may be contracted.
